we responded to was 92. We spent 98 hours in service and we logged 1,289 total man hours.

These dedicated fire fighters must spend additional time training and learning the skills needed to respond to the various types of emergencies that they may be called upon to help. The men put in an average of 75 hours per member training. These figures do not include the extra hours put into maintaining and servicing the equipment and hours spent in additional fundraising events to meet the needs of the Terre Hill Fire Company operating budget.

Because of their quick response, Terre Hill Firemen had an estimated value of property saved equal to \$1,480,000.

We ask again for your support in this years Annual Fund Drive, which makes up the backbone of our operational funding for the year.
